POLICIES

- ◆ Travel agents are eligible to receive reduced rates of 50% off the 2010 2-for-1* fares for Viking's Europe, Russia or China itineraries. (*2-for-1 fares per 2010 River Cruise Atlas.)
- ◆ Fares are per person, based on double occupancy and include port charges. 2-for-1 pricing applies to cruise/cruisetour portion only. Single supplement at 200% of reduced rate.
- ◆ Reduced rate is available to agent with current, valid IATA/CLIA card and one traveling companion sharing the same stateroom. Application must include a copy of current and valid IATA/CLIA card to process.
- ◆ Reduced rate does NOT include Visa fee for entrance to China and Russia.
- ◆ **Bookings are confirmed within 90 days prior to departure only.** Space is first-come, first-served, and pending availability.
- ◆ **Payment in full is due at time of booking. All reservations made under the reduced travel agent rate are non-refundable and subject to a 100% cancellation fee.**
- ◆ Roundtrip air, transfers and extensions are available for purchase at brochure prices.
- ◆ If booking own air, airport/ship transfers available for purchase on embarkation/debarkation dates only.
- ◆ Travel Insurance is not available on reduced rate programs.
- ◆ All components associated with reduced rate bookings are not commissionable.
- ◆ Once paid, the price cannot be adjusted to reflect any newly reduced rates or FAM rates.
- ◆ Reduced rate is not combinable with any other discounts or programs including Past Guest Travel Credit, Early Booking Discount, Group Discounts or Tour Conductor credits, cruise vouchers or certificates.
- ◆ **Space is capacity controlled and staterooms may be reassigned or withdrawn by Viking River Cruises at any time.**
