## **BOOKING PROCEDURE**

- MUST BE BOOKED in Agent Access, <u>www.suncountry.com/agentaccess</u> and click on Sun Country Vacations
- Air seats are booked first, & enter customers names, first, last, gender and DOB
- In Home Phone Field, YOU MUST ENTER YOUR TRAVEL AGENCY PHONE
- Email area, please enter agency email address (not the customer)
- Other phone field, you can place the customer phone here
- Address Field, is YOUR CUSTOMERS HOME BILLING INFORMATION
- Continue to book vacation package and place Customers Information in the applicable fields
- MUST PRINT COPY OF YOUR CONFIRMATION

## TRACKING FORM AND SUBMITTING FOR COMMISSION

- See attached tracking form and complete in its entirety otherwise commission will not be paid. Make extra copies of this tracking form for future use each month
- All bookings for your Agency MUST BE SUMMITED ON INDIVIDUAL TRACKING FORMS
- YOU MUST ATTACH A COPY OF EACH PACKAGE BOOKING YOUR AGENCY BOOKS. THIS IS THE ONLY RECORD OF YOUR BOOKING IN ORDER TO EARN COMMISSION. (KEEP A SECOND COPY FOR YOUR FILE.)
- All bookings that have COMPLETED TRAVEL BY the 15<sup>th</sup> OF EACH MONTH should then be sent to Sun Country Airlines and MUST ARRIVE BY THE 20<sup>TH</sup> OF EACH MONTH in order to process commission on the next months check. (Any form received after the 20<sup>th</sup> will not be processed until the month after that.)
- Bookings may be sent in when completed and we will track for future travel.
